Preliminary results of operations indicate the loss for the year ended December 31, 2002 is estimated to be approximately \$2,318,000 compared to the loss for the preceding year of \$2,024,882, representing an increase of approximately \$293,000 or 14%. The increased loss is primarily attributable to: sales decline of approximately \$592,000; write-down of inventory in the second quarter of approximately \$235,000 with the balance attributable to reduced gross profit margins and investment income as well as a \$25,000 decrease in income from the sale of state tax credits. Losses were in part mitigated by a decrease

in research expenditures of approximately \$167,000 and and a decrease of \$406,000 in litigation losses.
