Preliminary results of operations indicate the loss for the three months ended June 30, 2004 is estimated to be approxiamtely \$174,000 compared to the loss for the corresponding period of the preceding year of approximately \$230,000, representing a decreased loss of approximately \$54,000. The decreased loss is primarily attributable to reductions in selling, general and administrative expenses.
