Explanatory Note

This Current Report on Form 8-K/A is being filed by Village Bank and Trust Financial Corp. (the "Company") as an amendment (the "Amendment") to the Current Report on Form 8-K that the Company filed with the Securities and Exchange Commission on May 27, 2014 announcing the preliminary voting results of the Company's 2014 Annual Meeting of Shareholders (the "2014 Annual Meeting"). This Amendment is being filed to report the final voting results for the 2014 Annual Meeting.

Item 5.07 Submission of Matters to a Vote of Security Holders.

The Company held its 2014 Annual Meeting on May 20, 2014 at the Village Bank at Watkins Centre, 15521 Midlothian Turnpike, Midlothian, Virginia. A quorum of shares was present or represented by proxy at the 2014 Annual Meeting. At the 2014 Annual Meeting, the shareholders of the Company elected five directors to serve for three-year terms, approved an advisory vote on the Company's executive compensation, approved an amendment to the Company's Articles of Incorporation to authorize the board of directors to effect a reverse stock split of the Company's common stock, approved an amendment to the Village Bank and Trust Financial Corp. Incentive Plan to increase the number of shares of common stock reserved for issuance under the plan from 555,000 to 780,000, and ratified the appointment of BDO USA, LLP as the Company's independent registered public accounting firm for 2014.
