Capital Expenditures

On March 3, 2005, SK Telecom Co., Ltd. announced that, for the period of March through July of 2005, it plans to incur capital expenditures in the amount of (i) Won 174,643,000,000 for the facilities related to services of W-CDMA, commonly referred to as third generation wireless technology, and (ii) Won 187,496,000,000 to enhance the capacities and qualities of mobile phone services, respectively.
