### **Item 8.01. Other Events.**

As previously announced, on June 12, 2018, the Company and Project Almond Merger Sub LLC, a newly formed Illinois limited liability company and wholly-owned subsidiary of the Company (“Merger Sub”), entered into an Agreement and Plan of Merger (the “Merger Agreement”) with SCB, pursuant to which, among other things, the Company agreed to acquire 100% of the issued and outstanding shares of SCB pursuant to a business combination whereby SCB will merge with and into Merger Sub, whereupon the separate corporate existence of SCB will cease and Merger Sub will continue as the surviving company and a wholly-owned subsidiary of the Company (the “Merger”).

On October 24, 2018, the Company and SCB issued a joint press release announcing that the deadline for SCB stockholders to elect the form of merger consideration they wish to receive in connection with the Merger will be 5:00 p.m. central time on Wednesday, November 7, 2018, and that, subject to customary closing conditions, the companies have scheduled Thursday, November 15, 2018, as the closing date for the merger. A copy of the press release making this announcement is attached hereto as Exhibit 99.1 and incorporated into this Item 8.01 by reference.
