(1) These shares were converted in the merger into the right to receive cash consideration of \$27.85 per share, without interest.

(2) These restricted stock units were accelerated and cancelled in the merger in exchange for the right to receive an aggregate amount in cash, without interest, of \$379,192, equal to the merger consideration of \$27.85 for each restricted stock unit. Prior to the acceleration, the restricted stock units had vesting schedules as follows: 10,255.229 with a vesting date of 6/16/07; 1,186.000 with a vesting date of 2/15/08; 880.000 with a vesting date of 2/16/09; and 1,294.291 with a vesting date of 2/12/10.
