- Disposition of shares of common stock in a merger of one of the issuer's subsidiaries into the issuer to effect the formation of a holding company (the "Holding Company Merger"). ("Sally Beauty Holdings") pursuant to an Investment Agreement dated as of June 19, 2006, as amended, among the issuer and certain of its subsidiaries and CDRS Acquisition LLC.

  - (2) This option was assumed by Sally Beauty Holdings, in the Holding Company Merger and replaced with an option to purchase a number of shares of common stock of Sally Beauty Holdings equal to the number of shares subject to this option at an exercise price equal to the exercise price of this option.

  - (4) Convertible, at the election of the holder, into shares of common stock on a one-for-one basis or cash on the date of the reporting person's retirement as a director.
  - (5) This phantom stock was assumed by Alberto-Culver Company (formerly known as New Aristotle Holdings, Inc. ("New Alberto-Culver")) and replaced with phantom stock of New Alberto-Culver and mutual fund accounts pursuant to the Deferred Compensation Plan For Non-Employee Directors which became effective on November 16, 2006.
