- (1) Restricted stock units awarded pursuant to the Markel Corporation Omnibus Incentive Plan. Subject to certain conditions, twenty percent of the restricted stock units will vest on May 10, 2011, and the balance will vest on May 10, 2015.  
In addition to the grant of 2,780 restricted stock units reported herein, the total also includes 2,933 other restricted stock units granted pursuant to the Markel Corporation Omnibus Incentive Plan, of which 365 units will vest on December 31, 2010, 1,204 units will vest on December 31, 2011, and 1,364 units will vest on December 31, 2012.
- (3) Holdings under the Markel Corporation 401(K) Plan are reported in units. The information reported herein is based on a plan statement dated as of March 31, 2010 and utilizes the closing stock price on that date of \$374.66. As of 3/31/2010, a unit under the Plan represented one share of Common Stock.
