(1) during any calendar year of the performance period, the Issuer achieves one or more of the financial performance objectives that have not previously been achieved, a specified number of shares underlying the PBRsUs will vest and become payable on December 31 of that year.

Includes 35,082 time-based restricted stock units (each a "TBRSU"). Mr. Nallathambi received an award of TBRSUs on March 3, 2010, that vests in three equal annual increments, commencing on the first anniversary of the grant date. On June 1, 2010, pursuant to the

(2) anti-dilution provisions of the plan under which the TBRSU award was granted, the number of TBRSUs underlying this award was adjusted in conjunction with the Issuer's spin-off of First American Financial Corporation on that date. The vesting schedule of the TBRSU award remains unchanged.

(3) This option vests in three equal annual increments commencing June 1, 2012, the second anniversary of the grant date.
