- (1) On July 27, 2010, the Compensation Committee of the Board of Directors of the Issuer authorized and confirmed that the performance metrics were met with respect to 5,000 of the 10,000 Performance Shares (the "2008 Shares") granted to Mr. Richarz on September 12, 2008 and reported on Mr. Richarz's Form 4 dated September 16, 2008.
