These shares were granted as market share units and vest one-hundred percent on May 31, 2016, subject to acceleration and cancellation upon the occurrence of certain events. Each market share unit converts into the number of shares of common stock determined by

  - (1) applying a payout factor to the target number of shares on the vesting date, ranging from 0% to 200% of the number of market share units granted. The payout factor is the ratio of the average of the closing prices during the 90-day period immediately preceding the vesting date divided by the average of the closing prices during the 90-day period immediately preceding the date of grant.
  - (2) This grant was made after markets had closed.
