- (1) The transactions reported on this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on December 14, 2012.
The sale prices reported in column 4 of Table 1 represent the weighted average sale price of the shares sold ranging from \$98.07 to \$99.03 and \$99.09 to \$99.79, per share, respectively.
