Passeri, the chief executive officer of the Company, entered into a letter agreement effective as of December 31, 2013 (the Letter Agreement), pursuant to which the parties mutually agreed to extend the term of Mr. Passeri s employment agreement dated as of September 18, 2007, as amended October 27, 2008, December 16, 2010 and January 18, 2013, until December 31, 2014.
