As previously announced on January 22, 2015, Fifth Third Bancorp (Fifth Third) entered into an accelerated share repurchase transaction with Wells Fargo Bank, National Association (Wells Fargo) pursuant to which Fifth Third would purchase approximately \$180 million of its outstanding common stock. Fifth Third is repurchasing the shares of its common stock as part of its 100 million share repurchase program, previously announced on March 18, 2014.

On April 23, 2015, Fifth Third was notified by Wells Fargo that effective Thursday, April 23, 2015, they had finished purchasing shares under the January 22nd agreement. A total of 8,542,713 shares were repurchased upon execution of the agreement, and an additional 1,103,744 shares were repurchased upon completion of the agreement. The additional shares are expected to settle on Tuesday, April 28, 2015. In total, 9,646,457 shares were repurchased under the January 22, 2015 agreement, at an average price of \$18.6597.

After the completion of the January 22nd agreement, Fifth Third had approximately 62.7 million shares of remaining repurchase authority under its share repurchase program previously announced on March 18, 2014.

Wells Fargo and certain of its affiliates have performed, and in the future may perform, various financial advisory and other services for Fifth Third and Fifth Third s affiliates for which they have received, and may in the future receive, customary fees and expenses.
