**Item 1.01: Entry Into a Material Definitive Agreement.**

On June 19, 2015, Alliance HealthCare Services, Inc. (the Company, we, or our ) entered into a second amendment to its existing senior secured credit facility with Credit Suisse AG, Cayman Islands Branch, as administrative agent, and the other lenders party thereto in order to obtain an incremental \$30 million term loan that will be used to pay down all borrowings under its revolving credit facility, to pay fees and expenses related to the incremental term loan, and expects to use the remaining proceeds for general corporate purposes.

The incremental term loan closed and funded on Friday, June 19th. The incremental term loan funded at 99.5% of principal amount and will mature on the same date as the existing term loans in June 2019. The incremental term loan was converted to match all the terms of existing term loans. Interest on the incremental term loan is calculated, at the Company's option, at a base rate plus a 2.25% margin or LIBOR plus a 3.25% margin, subject to a 1.00% LIBOR floor.

The quarterly amortization payments of the term loans increased to \$1.3 million from the current amount of \$1.225 million.

The Company's obligations under the incremental term loan will be guaranteed by substantially all of our direct and indirect domestic subsidiaries. The obligations under the incremental term loan and the guarantees are secured by a lien on substantially all of our tangible and intangible property, and by a pledge of all of the shares of stock and limited liability company interests of our direct and indirect domestic subsidiaries, of which we now own or later acquire more than a 50% interest, subject to limited exceptions.
