On January 25, 2016, Mr. John A. Canning, Jr., a director of Exelon Corporation (Exelon) informed the board of directors that he will not stand for election as a director of Exelon at the 2016 annual meeting of shareholders.

On January 26, 2016, the board of directors of Exelon elected Ms. Nancy L. Gioia as a director, effective as of February 1, 2016, to fill the vacancy resulting from the retirement on December 31, 2015 of Dr. William C. Richardson, to serve until the 2016 annual meeting of shareholders. Ms. Gioia has been appointed to serve on the Finance and Risk and Generation Oversight committees of the board of directors. Ms. Gioia will receive Exelon's standard compensation for its directors as disclosed in its proxy statement.
