## Novo Nordisk A/S – share repurchase programme

On 2 February 2011 Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission's regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules.

Under the programme Novo Nordisk will repurchase B shares for an amount up to DKK 2.0 billion in the period from 2 February 2011 to 26 April 2011.

Since the announcement as of 28 February 2011, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 28,508,032 treasury shares, corresponding to 4.8% of the share capital. The total amount of shares in the company is 600,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares worth DKK 10.0 billion during 2011. As of 4 March 2011, Novo Nordisk has repurchased a total of 1,259,500 B shares equal to a transaction value of DKK 822,504,959.
