Novo Nordisk A/S – Share repurchase programme

Bagsværd, Denmark, 22 July 2013 – On 3 May 2013, Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission’s regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules. This programme is part of the overall share repurchase programme of up to DKK 14.0 billion to be executed during a 12-month period beginning 31 January 2013.

Under the programme initiated 3 May 2013, Novo Nordisk will repurchase B shares for an amount up to DKK 3.0 billion in the period from 6 May 2013 to 6 August 2013.

Since the announcement as of 15 July 2013, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 15,707,661 treasury shares, corresponding to 2.9% of the share capital. The total amount of shares in the company is 550,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares for an amount up to DKK 14.0 billion during a 12-month period beginning 31 January 2013. As of 19 July 2013, Novo Nordisk has

repurchased a total of 8,190,310 B shares equal to a transaction value of DKK 7,919,760,870.
