Of the 23,374,450 shares of Class B Common Stock reported in Table I, (A) Mr. Doyle beneficially owns 6,415 shares of Class B common stock, all of which were redeemed by the Company on March 16, 2006, and (B) Coinmach Holdings, LLC ("Holdings") (1) beneficially owns 23,368,035, all of which beneficial ownership Mr. Doyle disclaims, except to the extent of any pecuniary interest therein. Mr. Doyle owns approximately 1% of the outstanding Class A Common Units and less than 1% of the outstanding Class C Preferred Units of Holdings.
