- (1) On March 31, 2005, the reporting person filed a Form 4 reporting the grant of 933 shares of performance-based restricted stock. Since the restricted stock grant was performance-based, the shares are not considered beneficially owned by the reporting person until the shares become vested and therefore, should not have been reported in a Form 4 on the date of grant.
