Mr. Doan has been granted a total of 30,000 restricted stock units in four grants: (A) 2,000 restricted stock units granted on May 24, 2006 which vest annually in four equal installments beginning on May 24, 2007 (1,000 of which have vested as of this filing); (B) 16,000 restricted stock units on May 2, 2007 which vest annually in four equal installments beginning on May 2, 2008 (8,000 of which have vested as of this filing); (C) 6,000 restricted stock units on May 7, 2008 which vest annually in four equal installments beginning on May 7, 2009 (1,500 of which have vested as of this filing); and (D) 6,000 restricted stock units on May 6, 2009 which vest annually in four equal installments beginning on May 6, 2010.
