The shares of common stock were placed into an account of Triam Management (as defined in Note 2 below) for the benefit of the Triam Entities (as defined in Note 2 below) pursuant to an agreement between Mr. Peltz and Triam Management with respect to the fees received by Mr. Peltz for serving on the Board of Directors of the Issuer.
- (2) Triam Fund Management GP, LLC ("Triam Management GP") is the general partner of Triam Fund Management, L.P. ("Triam Management"), which serves as the management company for Triam Partners, L.P.
