(3) The Human Resources Committee granted Dr. Klein 2,045 Restricted Stock Units. Each Restricted Stock Unit is the economic equivalent of one share of Pinnacle West common stock. The Restricted Stock Units will be settled in shares of common stock on the last business day of the month following the month in which the reporting person separates from service from the Company. The grant includes 51 Restricted Stock Units in respect of dividends on Pinnacle West common stock since July 1, 2010.
