(1) The acquisition of the 5,000 shares of common stock reported herein reflects an award of restricted stock on June 15, 2011, pursuant to the Company's 2009 Restricted Stock/Unit Plan. The award vests in one-third annual installments beginning on the first anniversary of the grant date, subject to the participant's continued employment with the Company and subject to accelerated vesting upon the death, disability or retirement of the participant, or upon a change in control of the Company.

(2) Granted pursuant to the Company's 1998 Stock Option Plan. The option vests and becomes exercisable in three equal annual installments beginning on the first anniversary of the grant date. Vesting accelerates under certain circumstances.
