(1) Each deferred unit is the equivalent of one share of the Company's common stock. On August 10, 2011, 413,938 of the reporting person's deferred units were settled for cash based upon the Company's closing stock price on the New York Stock Exchange on August 5, 2011.

(14) Each deferred unit will be settled in cash as soon as practicable after, and in any event within 90 days after, the second anniversary of the grant date (February 25, 2010) for an amount equal to the Company's closing stock price on the New York Stock Exchange on the settlement date. Deferred units are fully vested when credited.

(15) One-third of the deferred unit award will be settled in cash as soon as practicable after, and in any event within 90 days after, the first, second and third anniversaries of the grant date (May 3, 2010) based on the Company's closing stock price on the New York Stock
