(1) On February 10, 2012 Mr. Kloepfel exercised options to purchase 20,000 shares of the Company's common stock, having an exercise price of 22.95 per share. Mr. Kloepfel paid the exercise price for such option and the applicable tax to be withheld by surrendering 16,727 of such shares. Mr. Kloepfel retained the remaining 3,273 shares.

(2) Does not include 56,250 shares of common stock issuable upon the vesting of restricted stock unit awards, with both a performance-based and time-based vesting schedule, originally granted on February 4, 2008 and amended on September 3, 2010.
