(1) This represents the difference between the number of SARs exercised (3,000) and the number of shares issued as a result of the exercise (1,692). The number of shares to be issued under a SAR exercise is determined by multiplying the number of SARs being exercised by the difference between the FMV on the date of exercise (\$64.32) and the exercise price (\$11.92). Additional shares are then withheld to satisfy the Company's tax withholding obligations.

(2) 3,000 SARs became exercisable on February 24, 2010 and 3,000 SARs became exercisable on February 24, 2011 and 3,000 SARs became exercisable on February 24, 2012.
