(1) This amount represents the \$30.00 secondary public offering price per share less the underwriting discount of \$0.975 per share.

(2) Consists of 7,000 shares of common stock and 764 restricted stock units. Each restricted stock unit represents the right to receive, upon vesting, one share of common stock. These restricted stock units will vest over three years, with one-third vesting on March 4, 2015; one-third vesting on March 4, 2016; and the remaining one-third vesting on March 4, 2017, assuming continued employment through the applicable vest date.

(3) The reporting person is exercising options that are presently exercisable. Of the remaining options after giving effect to this transaction, 12,833 are presently exercisable and 3,209 become exercisable at the end of the calendar quarter ending September 30, 2014.

(4) The reporting person is exercising options that are presently exercisable. Of the remaining options after giving effect to this transaction, 3,416 are presently exercisable; 5,500 will become exercisable in equal quarterly installments at the end of each calendar quarter through June 30, 2015; and 5,500 vest at the end of fiscal 2014 or fiscal 2015, provided certain corporate performance targets are met.
