- Acquisition in connection with the merger (the "Merger") contemplated by the Transaction Agreement and Plan of Merger among Horizon Pharma, Inc., Vidara Therapeutics Holdings LLC, the Issuer (formerly known as Vidara Therapeutics International Ltd.), Hamilton Holdings (USA), Inc. and Hamilton Merger Sub, Inc. Pursuant to the Merger, the outstanding securities of Horizon Pharma, Inc. are being canceled and automatically converted into securities of the Issuer.
- (1) The stock option vested in 12 equal monthly installments following the vesting commencement date of 6/6/10, and is fully vested and exercisable.
 - (2) In connection with the Merger, the stock option originally granted by Horizon Pharma, Inc. has been converted into an option to purchase the same number of ordinary shares of the Issuer at the same exercise price and on substantially the same terms.
 - (3) 25% of the shares subject to the stock option vest on 5/19/2015, and the remaining shares vest in 36 equal monthly installments thereafter.
 - (4) The stock option vests in 48 equal monthly installments following the vesting commencement date of 1/10/14.
 - (5) 25% of the shares subject to the stock option vest on 9/12/2015, and the remaining shares vest in 36 equal monthly installments thereafter.
 - (6) Each restricted stock unit represented a contingent right to receive one share of Horizon Pharma, Inc. common stock. Each restricted stock unit has been converted into a contingent right to receive one ordinary share of the Issuer.
 - (7) The restricted stock units vest in four equal annual installments.
