- (1) Restricted stock units of ExlService Holdings, Inc. (the "Company") convert into common stock, par value \$0.001 per share (the "Common Stock") on a one-for-one basis.  
  
The reporting person's restricted stock units reported in this report vested on February 7, 2015. Pursuant to the Company's 2006 Omnibus Award Plan, pursuant to which such restricted stock units were granted, the average of the high and low sale prices of the Common Stock on the Nasdaq Global Select Market on the preceding day is used for purposes of computing tax reporting and withholding.
  - (3) On February 7, 2012, the reporting person was granted 12,500 restricted stock units, vesting in 10%, 20%, 30% and 40% beginning on the first anniversary of the grant date. The remaining balance *i/n/o* 5,000 shares of restricted stock units will vest on February 7, 2016.  
  
On February 7, 2012, the reporting person was granted 2,450 restricted stock units, vesting in three annual installments beginning on the first anniversary of the grant date. 816 shares of the restricted stock units became vested on February 7, 2013, an additional 817 shares of the restricted stock units became vested on February 7, 2014, and the remaining balance *i/n/o* 817 shares of restricted stock units became vested on February 7, 2015.
