Of the grant of restricted stock, 75% is subject to vesting based on GEO's total shareholder return over a three-year period and 25% is subject to vesting based on certain return on capital employed performance goals being met.
 - (2) The amount of shares has been adjusted to reflect the March 2, 2015 vesting of 625 shares of restricted stock.
 - (3) These shares were surrendered in order to satisfy the reporting person's tax withholding obligation upon the vesting of restricted stock.
