(1) These shares were acquired pursuant to a restricted stock unit award under the Company's 2007 Stock Incentive Plan. Each restricted stock unit represents a contingent right to receive one share of the Company's Common Stock. The restricted stock units vest over four (4) years beginning on January 1, 2014, at a rate of twenty-five percent (25%) after 12 months and in thirty-six (36) equal monthly installments thereafter.

(2) The Form 3 filed by the reporting person on October 8, 2014 and the Form 4 filed by the reporting person on March 23, 2015 included a restricted stock unit award in the amount of 40,000 shares. This award as reported on these forms inadvertently did not reflect reflect the Company's 1-for-3 stock split that was effective September 25, 2014.
