## Explanation of Responses:

(1) As previously reported, on March 1, 2017, the reporting person received a grant of 43,883 time-based restricted stock units that vest in one-third increments on each of the first, second and third anniversaries of the date of grant. The first anniversary occurred on March 1, 2018, resulting in the vesting and settlement of 14,627 shares of common stock, as shown in Table I. The remaining 29,256 restricted stock units are shown in Table II, of which 14,628 are scheduled to vest on each of March 1, 2019 and March 1, 2020.

(2) Restricted stock units convert into common stock on a one-for-one basis.

(3) Shares withheld for payment of taxes upon vesting of restricted stock units in accordance with Rule 16b-3.

(4) Time-based restricted stock units are settled in shares of the Company's common stock upon vesting.
