ITEM 1. SECURITY AND ISSUER.

The security upon which this report is based is the common stock, par value \$0.001, of Euro Trend Inc., a Nevada corporation, with its principal place of business located at 875 Merrick Avenue, Westbury, NY 11590. The telephone number is (727) 934-9593.

This Schedule 13D relates to the Share Exchange Agreement between Euro Trend Inc., a Nevada Corporation, Data Storage Corporation, a Delaware Corporation and the shareholders of Data Storage Corporation, pursuant to which 100% of the outstanding common shares of the Data Storage were acquired by Euro Trend Inc. Jan Burman was issued 20,877,658 shares of Euro Trend Inc., in exchange for his 406,245 Class B common stock shares and 360,255 Series A preferred stock of Data Storage Corporation.

ITEM 2. IDENTITY AND BACKGROUND.

The name of the person filing this statement is Jan Burman who is hereinafter sometimes referred to as the "Reporting Person." Jan Burman with a principal place of business located at 875 Merrick Avenue, Westbury, NY 11590. The telephone number is (212) 564-4922.

During the past five years, the Reporting Person has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors). In addition, the Reporting Person has not been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction during the last five years which would make it subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violations with respect to such laws.

The Reporting Person is a citizen of the United States.

ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION.

The shares were issued to Jan Burman pursuant to the Share Exchange Agreement between Euro Trend Inc., a Nevada Corporation, Data Storage Corporation, a Delaware Corporation and the shareholders of Data Storage Corporation, pursuant to which 100% of the outstanding common shares of the Data Storage were acquired by Euro Trend Inc. Jan Burman was issued 20,877,658 shares of Euro Trend Inc., in exchange for his 406,245 Class B common stock shares and 360,255 Series A preferred stock of Data Storage Corporation.

ITEM 4. PURPOSE OF TRANSACTION.

The acquisition of 20,877,658 shares of the Issuer's common stock by the Reporting Person were issued the Share Exchange Agreement between Euro Trend Inc., a Nevada Corporation, Data Storage Corporation, a Delaware Corporation and the shareholders of Data Storage Corporation, pursuant to which 100% of the outstanding common shares of the Data Storage were acquired by Euro Trend Inc. Jan Burman was issued 20,877,658 shares of Euro Trend Inc., in exchange for his 406,245 Class B common stock shares and 360,255 Series A preferred stock of Data Storage Corporation and the shares were valued at par value.

ITEM 5. INTEREST IN SECURITIES OF THE ISSUER.

The Reporting Person acquired 20,877,658 of the issued and outstanding common shares of the Issuer. Such amount represented 22 % of the total issued and outstanding common shares of the Issuer.

ITEM 6. CONTRACTS, ARRANGEMENTS, UNDERSTANDINGS OR RELATIONSHIPS WITH RESPECT TO SECURITIES OF THE ISSUER.

Other than the Agreement, as described in this Schedule 13D, the Reporting Person has no contracts, arrangements, understandings or relationships with any other person with respect to any securities of the Issuer.
