- (1) Assumes conversion of all of the holder's LYONs at a conversion rate of 13.4108 shares of common stock per \$1,000 principal amount at maturity of the LYONs as a result of a 2-for-1 forward split on May 10, 2002. This conversion rate is subject to adjustment, however, as described under "Description of LYONs-Conversion Rights-Conversion Adjustments and Delivery of Common Stock" beginning on page 16 of the prospectus. As a result, the number of shares of common stock issuable upon conversion of the LYONs may increase or decrease in the future.
- (2) Calculated based on Rule 13d-3(d) (1) (i) of the Exchange Act using 136,394,820 shares of common stock outstanding as of December 28, 2004. In calculating this amount for each holder, we treated as outstanding the number of shares of common stock issuable upon conversion of all of that holder's LYONs, but we did not assume conversion of any other holder's LYONs.

The Aggregate Principal Amount represents the remaining assets in this account that were transferred to Saranac Capital Management L.P. as a result of a spin-off. Saranac Capital Management L.P. acts as a discretionary investment advisor and may be deemed to act on the behalf of the beneficial owner of such debentures.
