- (1) the number of units which would have been credited if the deferred amounts had been invested in the Issuer's company stock fund in its Thrift Plan (the "Stock Fund"). The Stock Fund is accounted for in units of a unitized pool of stock and cash. Phantom Stock Units are estimated based on the number of shares of the Issuer's common stock in the Stock Fund and the number of theoretical units credited to the reporting person. Accounts are payable in cash at the end of the deferral period.
  - (2) Closing price of Issuer's common stock on NYSE on the relevant date (price used to value units in the Stock Fund).
  - (3) Differences in holdings between any given dates may result from varying percentages of cash and stock held in the Stock Fund on those dates.
