(1) The Reporting Person was granted 27,604 shares of Restricted Common Stock under the 2013 Stock-Based Incentive Compensation Plan. 9,737 shares vest over a three year period as follows: 3,246 shares on January 3, 2015 and January 3, 2016, respectively, and 3,245 shares on January 3, 2017. The final 17,867 shares vest on January 3, 2017 based on the Company's Total Shareholder Return versus a defined peer group of companies, with the final number of performance based vested shares varying from 0 to 200% of 17,867.
