**GOL ANNOUNCES 38% INCREASE IN SHUTTLE SERVICE BETWEEN SÃO PAULO AND RIO DE JANEIRO**

**São Paulo, November 18, 2004** GOL Linhas Aéreas Inteligentes S.A. (NYSE: GOL and Bovespa: GOLL4), Brazil's low-fare, low-cost airline, will expand its shuttle service São Paulo – Rio de Janeiro on November 22 by offering ten new daily shuttle flights to meet growing demand. GOL's current load factor of 75% on this route was an important factor in obtaining the DAC's (Civil Aviation Department) approval for these additional routes. We expect this new capacity to translate into 30 thousand extra passengers per month, primarily business travelers, which today represent approximately 60% of the Company's passenger mix. With these new flights, GOL will offer 36 daily flights on this route.

The commencement of these ten new daily flights on our São Paulo – Rio de Janeiro shuttle service represents important growth for GOL in the largest core market in Brazil. These 10 new shuttle flights will allow GOL to better serve customers who frequently fly this route, as passengers will be able to count on more flight options and smaller intervals between flights. GOL Linhas Aéreas Inteligentes, a low-cost, low-fare airline, is one of the most profitable and fastest growing airlines in the industry worldwide. Add to this safe and reliable service, stimulating GOL's brand recognition and customer satisfaction, and GOL has the best cost-benefit service in the market. GOL currently offers service to 36 major business and travel destinations in Brazil, with substantial expansion opportunities. By the year-end, GOL plans to grow by increasing frequencies in existing markets and adding service to additional markets in both Brazil and other high-traffic South American travel destinations. GOL listed its shares on the NYSE and the Bovespa in June 2004.
