Gentlemen,

The Board of Directors of this Bank, in a meeting held today, approved the Board of Executive Officer's proposal for the payment to the Company's stockholders of Intermediary Dividends related to the first half 2007, **in the amount of R\$0.153223130 per common stock and R\$0.168545440 per preferred stock**, benefiting the stockholders registered in the Bank's Books on this date (June 27<sup>th</sup>, 2007).

The payment will be settled on July 23<sup>rd</sup>, 2007, according to the declared amount, with no Withholding Income Tax under the terms of the Article 10 of Law # 9,249/95.

The aforementioned Dividends represent ten times the amount of Interest on Own Capital monthly paid already deducting fifteen percent (15%) of Withholding Income Tax.

The Dividends related to the stocks deposited at CBLC (Brazilian Company and Depository Corporation) will be paid to the referred CBLC, which will transfer them to the stockholders by means of depositor Brokerage Houses.
