**MEXICO CITY, MEXICO, August 26, 2008 --** América Móvil, S.A.B. de C.V. (AMX) (BMV: AMX; NYSE: AMX; Nasdaq: AMOV; LATIBEX: XAMXL), announced that its Ecuadorian subsidiary, *Consortio Ecuatoriano de Telecomunicaciones, S.A. CONECEL* (Conecel), has executed with the Ecuadorian Telecommunications Agency (*Secretaría Nacional de Telecomunicaciones*), a new concession agreement that grants Conecel the right to provide mobile telecommunications services in Ecuador for a 15-year term.
