(1) On June 30, 2009, a prior Form 4 was mistakenly re-filed by the issuer's filing agent on behalf of the reporting person, which reported a series of stock purchases by the reporting person totaling 3,000 shares of common stock. Such purchases were previously reported on a Form 4 filed with the SEC on June 3, 2009, and should not have been included on the June 30, 2009 Form 4. The June 30, 2009 Form 4 should have included only the grant of Deferred Stock Units ("DSUs") on June 27, 2009.

(2) This grant of DSUs was made pursuant to the Tasty Baking Company Deferred Stock Unit Plan for Directors (the "Plan"). Each DSU represents the right to receive one (1) share of Tasty Baking Company common stock. The DSUs will vest on the completion by the reporting person of five (5) years of continuous service as a director. The reporting person has served as a director since May 2005.
