- (1) The Reporting Person was awarded a grant of 9,480 restricted stock units (RSUs). The RSUs vest over a four year period according to the following schedule: 30%, 30%, 20% and 20%. Each RSU represents the contingent right to receive one share of RGS common stock upon vesting.
 - (2) Includes 65 shares attributable to employee stock plan purchases since the filer's last Form 4.
 - (3) The Reporting Person was awarded a grant of 3,700 restricted stock units which vest ratably over a three year period. Each RSU represents the contingent right to receive one share of RGS common stock upon vesting.
 - (4) Stock Appreciation Rights vest ratably over a three year period.
