- (1) These common shares were delivered to the issuer to pay for the applicable withholding tax due upon vesting of certain restricted stock units.

- (5) On December 19, 2011, the reporting person received a grant of 20,000 Restricted Stock Units ("RSU's") that vest on December 15, 2014.

- (7) The reporting person received a grant of 40,000 stock options on December 19, 2011 which vest 100% on December 15, 2014.
- (8) The reporting person received a grant of 50,000 stock options that vested in three equal annual installments beginning on August 11, 2011.
- (9) On December 11, 2014, the reporting person received a grant of 26,000 stock options. These stock options vest on December 10, 2017.
