- (1) Represents shares of common stock delivered to the issuer in payment by the reporting person of the options exercise price and withholding tax. This transaction is exempt under Rule 16b-3(e).

- (6) As reported on a Form 4 dated December 17, 2014, the reporting person received a grant of 13,000 Restricted Stock Units ("RSUs") that fully vest on December 10, 2017.
- (7) The reporting person received a grant of 40,000 stock options on December 19, 2011 which vested 100% on December 15, 2014. The reporting person exercised 15,000 of these stock options on February 19, 2015.
- (8) As reported on a Form 4 dated December 17, 2014, the reporting person received a grant of 26,000 stock options that fully vest on December 10, 2017.
