- (2) This amount includes 28.819 shares acquired by Mr. DeNaples individually through the DRP; and 314.837 shares acquired jointly with his spouse through the DRP. Therefore, Mr. DeNaples holds 5,342.034 shares individually and 58,360.603 shares jointly with his spouse.
- (3) Comprises 2,439 shares held by a business in which Mr. DeNaples is a 33.33% owner with his brother, Louis A. DeNaples.
