(1) Grant of stock units under the Issuer's 2009 Performance Incentive Plan (the "Plan"). Subject to the satisfaction of a performance requirement for the 2012 calendar year established by the Compensation Committee of the Issuer's Board of Directors, the units vest at the rate of 25% on each of January 9, 2013, 2014, 2015 and 2016. Promptly after vesting, the vested units will be paid on a one-for-one basis in shares of the Issuer's Common Stock.

(2) Consists of unvested restricted stock units that, upon vesting, will be paid on a one-for-one basis in shares of the Issuer's Common Stock.

(3) Includes 23,464 shares of the Issuer's Common Stock issued upon the vesting of certain restricted stock units.

(4) Each stock unit represents a contingent right to receive one share of the Issuer's Common Stock. 50% of the stock units will vest on December 31, 2012 if the Issuer's stock price appreciates 15% or more during calendar 2012. 100% of the stock units will vest on December 31, 2012 if the Issuer's stock price appreciates 25% or more during calendar 2012.
