The RSU shares vest as to (i) 25,000 shares if the vesting price equals or exceeds \$5.00 per share, (ii) 75,000 shares if the vesting price equals or exceeds \$10.00 per share and (iii) 150,000 shares on the later of (a) October 1, 2019 and (b) the date the vesting price equals or exceeds \$15.00 per share. The shares covered by the RSU would be issued following vesting as provided in the 2014 Equity Incentive Plan and RSU agreement
