On August 11, 2006, the Compensation Committee of the Board of Directors of Churchill Downs Incorporated (the "Company") approved a \$200,000 special recognition bonus for former President and Chief Executive Officer of the Company, Thomas H. Meeker, who as of August 14, 2006, began serving as a management advisor pursuant to the terms of his Amended and Restated Employment Agreement.
