There were 212,977,085 shares of the Company's common stock present or represented by proxy at the 2018 Annual Meeting. This represented approximately 90% of the Company's shares of common stock outstanding as of the record date of the 2018 Annual Meeting. Three proposals, as described in the Company's Proxy Statement dated April 13, 2018 (the "2018 Proxy Statement"), were voted upon at the 2018 Annual Meeting.
