## Explanation of Responses:

- (1) The shares vest at the end of four years subject to the performance of certain goals. If these goals are not attained, the shares will be forfeited.
  - (2) Holdings within the Franklin Electric Directed Investment Salary Plan Trust. The information reported herein is based on a plan statement reporting June 30, 2007 holdings under the Franklin Electric Directed Investment Salary Plan.
  - (3) Allocation of shares under the Franklin Electric Co., Inc. Employee Stock Ownership Plan Trust. The information reported herein was provided by the trustee for holdings as of June 30, 2007.
  - (4) The options become exercisable in three equal installments of 1/3 each year, beginning on the first anniversary of the grant date.
  - (5) The options become exercisable in four equal installments of 1/4 each year, beginning on the first anniversary of the grant date.
  - (6) The options become exercisable in five equal installments of 1/5 each year, beginning on the first anniversary of the grant date.
- Pursuant to terms of the Nonemployee Directors' Deferred Compensation Plan approved by the board of directors on February 11, 2000 and amended and restated on April 28, 2006, Mr. Trumbull elected to receive his 2000 board of directors retainer in Franklin Electric Co., Inc. common stock, issuance of such shares deferred until he retires or otherwise leaves the board of directors (e.g. Stock Units). On
- (7) November 15, 2007, Mr. Trumbull was credited with 5.07 Stock Units for dividends that would have been paid on such deferred shares. At distribution, Mr. Trumbull may elect pursuant to the terms of the Plan to receive his deferred compensation either in shares of Franklin common stock or in cash.
